Entries: Entries will not be accepted without fees. Faxed, telegraph, telephone, and unsigned entries cannot be accepted. Entries not on an Official AKC entry form, and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC entry form are not acceptable. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. No refund for duplicate entries, errors on entry blanks. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. No entries will be accepted which require a signature for delivery.

Test Worker Option: Per Chapter 1, Section 17d of the Regulations, one TDX track will be set aside for test workers. In the event no TD or TDU entries are received then two TDX tracks will be set aside for test workers. Anyone who assisted at the test site on plotting day and/or on test day for any Cornhusker Kennel Club tracking test held in the current (2025) or previous (2024) calendar year will be eligible. If necessary, a random drawing may be held to determine which test workers are chosen. The remaining workers will automatically be included in the drawing with all other tracking entries received. The test secretary must be notified by the worker of their intent to be considered for a test worker track.

Drawing of entries for TD/TDU/TDX Test: A drawing will be held at 7:30 PM, Thursday, March 13, 2025 at Burger King, 2045 S 17th St, Lincoln, NE to fill entry limits. The drawing shall be completely random among all entries received, and in accordance with provisions set forth in the Tracking Regulations Ch. 1, Sec 17. If the limit for entries is not reached in one test, and exceeded in the other, the number of tracks will be exchanged according to the limits set forth in Ch. 1 Sec. 17a. All entrants will be notified of the results of the draw by phone or email. Upon notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test.
